

**Terms & Conditions**  
**The Dinner Daily, Inc.**

1. The Dinner Daily, Inc is a meal planning subscription service offering various plans and terms. By signing up you are agreeing to be billed on a recurring basis in accordance with your subscription term. Three (3) month subscriptions will be billed every three months until cancelled, Six (6) month subscriptions will be billed every 6 months and Annual (12 months) subscriptions will be billed on the annual anniversary date.
2. All subscriptions offer a 14 day trial. You will not be charged the subscription fee for the first 14 days of your membership. **On day 15, unless cancelled within the first 14 days, you will be charged the subscription fee for the term you selected upon signing up for the service.**
3. The Subscription is to be used by the Subscriber or Subscriber's household only. The weekly menu or shopping list reports cannot be distributed, copied, or forwarded to another email address without permission from The Dinner Daily LLC. Sign in details for the site may not be shared beyond the subscriber's household. Our automated system will send us an alert if multiple IP addresses are logging in with the same user ID and password. If this policy is violated, we reserve the right to cancel your account immediately.
4. Menu Plans are available to subscribers by logging into the Member's Dashboard on our website at [www.thedinnerdaily.com](http://www.thedinnerdaily.com). Reports are posted on the site in accordance with the timetable on our site. It is the subscriber's responsibility to log into the site and retrieve the menu plans. As a courtesy, we will also email out menu reports to our subscribers when menu plans are posted each week. **Please note: this email is not considered the delivery of the menus and related reports.** To receive this reminder email, subscribers must opt in to our mailing list, available on our Thank you page after signing up.
5. By signing up for our service, you agree to allow us to email you from time to time with membership information or to let you know about new features.
6. Subscribers should print out the current week's menu reports each week if they would like to keep a copy of the menu and shopping list. We only store the current week and previous week's reports on the Member's only dashboard. Archived copies of menu reports cannot be emailed out to subscribers.
7. Refund Policy: For all term memberships, refunds cannot be issued after 14 days of starting the service. We cannot process refunds after this period expires.
8. At the end of our subscription service, your subscription will automatically be renewed and your account will be charged, unless you cancel before the renewal date. Subscribers are responsible for cancelling their subscription by filling out the form on the "Account Settings" page. If you signed up for our service using your Paypal account, you may also cancel by logging into your Paypal account or calling Paypal at 1-800-221-1161. Please note: unsubscribing to our mailing list DOES NOT cancel your account.

13. For the week of Thanksgiving, Christmas, and the 4<sup>th</sup> of July each year, weekly menus will only be issued with four (4) weeknight meals.
